Supplier Process



1. Product Selection

Supplier proposes products and Prospera makes a selection based on factors such as popularity and price.



2. Terms and Shipment

Discuss terms and agreement. Supplier ships to Prospera.



3. Monthly Update

A report is generated at the end of each month with quantity sold and inventory remaining.



4. Payment

Prospera deposits payment in supplier's bank (U.S. preferred) by the 3rd-5th of the following month.



5. Evaluation

Supplier evaluates and ships more products to Prospera.



6. Product Promotion

As products sell, account buyers will select SKUs to participate in promotion or store selection.
